3. Depreciation is not a reduction from Capital Fund. After debiting to Income & Expenditure Account, the excess of Income over Expenditure/ excess of Expenditure over Income added to/reduce from Capital Fund.
4. Fixed Assets schedule should have conventional financial heads arranged in a descending order from immovable to movable i.e. Land & Building, Plant & Machinery, Office Equipment, Audio Visual Equipment, Furniture & Fixtures, Computers, Vehicles and Library books etc. SAI may add heads specific to their activities.

- 6 "Corpus Fund" & "Earmarked / Endowment Funds" should be heads on the Liabilities side; the corresponding investments should appear under a separate head 'Investments from Corpus Funds & Earmarked/Endowment Funds' on the assets side of the Balance Sheet.
- 7 Depreciation be provided on Diminishing Balance Method at rates in the Income Tax Act and on additions during the year on Pro-rata basis. Income Tax Act allows Depreciation on Half yearly basis whereas Companies Act provided for Pro-rata basis.

APPROVAL OF ANNUAL ACCOUNTS AND FINANCIAL STATEMENT (2010-11) OF SPORTS AUTHORITY OF INDIA (SAI)

The Annual Accounts and financial statement (2010-11) of SAI were placed before the Finance Committee in its 58th Meeting held on 10th August 2011 for approval.
