Item No. 2

Action Taken Report on the decisions taken in the 58th Meeting of the Finance Committee (FC) of the Sports Authority of India (SAI) held on August 10, 2011 in the Chamber (Room No. 1-C) of Secretary (Sports), MoYAS, Shastri Bhavan, New Delhi

- (a) The action taken was noted.
- (b) On the action taken on the approval of budget allocation for the year 2011-12, Secretary, SAI briefed the Committee that the committee under the Chairpersonship of Additional Secretary (Expenditure), Ministry of Finance, met in February, 2012 to finalize the rationalization of booking of expenditure. The broad contours of the decisions taken in the meeting were explained. The rationalization of expenditure is based on the approvals granted by the Parliament for expenditure under Plan and Non-Plan heads. Further, the expenditure relating to developmental sports promotion schemes is to be met from Plan Head and expenditure relating to Establishment at Head Office, Pension, Maintenance of Staff Quarters and Loans & Advances to employees is to be met from Non-Plan Head.

Action taken report on the decisions taken in the 59th Meeting of the Finance Committee (FC) of the Sports Authority of India (SAI) held on September 19, 2011 under the Chairmanship of Hon'ble Minister of State for Youth Affairs & Sports (Independent Charge) in the Conference Room, 1st Floor, SAI Head Office, Lodhi Road, New Delhi

- (a) The action taken was noted.
- (b) The action taken for agenda item No. 8 "Implementation of the 'Come & Play' Scheme" was discussed. It was decided that as in the year 2010-11, the duration

of Diploma Course in Sports Coaching may be revised from 10 months to 12 months with 2 months of paid practical training from the academic session 2011-12. During the paid practical training period of 2 months, the trainees would be provided with free lodging, a sports kit for a maximum of Rs. 1,000/- and a stipend of Rs. 10,000/- per month. Since there is a requirement of coaches for the "Come & Play" Scheme, those coaches who successfully complete Diploma Course and are willing to continue to train the "Come & Play" trainees, may be engaged on contract basis for the next six months and they may be provided free lodging and a remuneration of Rs. 14,000/- per month. It was also decided that starting from academic session 2012-13, the duration of the Diploma Course in Sports Coaching may be increased from 10 months to 18 months. 8 months would be devoted to practical training and the trainees would be on internship during the period. During the period of internship, they would be provided free lodging in SAI Centres and a monthly stipend of Rs. 10,000/-.
