2.0 Shri Ajit M Sharan, Secretary (Sports), Ministry of Youth Affairs & Sports chaired the meeting.

5.0 At the outset, Executive Director (Finance), SAI welcomed the Chairman and members of the Committee. Thereafter, the agenda items were taken up for consideration and after deliberations, the following decisions were taken:

6.0 **Item No. 1**

Confirmation of the Minutes of the 68th Meeting of the Finance Committee (FC) of Sports Authority of India (SAI) held on September 9, 2014

The amendments suggested by Additional Secretary (Expenditure) with regard to supplementary item No.4 (1) was brought on record.

The Finance Committee confirmed the minutes of the 68th meeting of Finance Committee after considering the decision conveyed by AS (Exp.), MoF.

7.0 **Item No. 2**

Re-provisioning of Budget Allocation (2014-15) of Sports Authority of India (SAI) under Plan

FA (MYAS) intimated that keeping in view the expected ceiling in the budget the proposal may be deferred for the time being.



8.0 Item No. 3
Accounting & Financial Reforms in SAI - Development of Finance and Accounts Manual of SAI in-house

Concurred with the directions that Finance and Accounting Manual may be completed by 31st March 31.03.2015. The remuneration per person being paid is as per formula being adopted in Government Departments i.e. last pay drawn minus pension plus DA as applicable.

9.0 Item No. 4
Setting Up of SAI Kerala Regional Centre - issue of formal notification granting the Regional Head quarter status to SAI LNCPE as SAI Kerala Regional Centre

During discussion it was transpired that there is a need to consider the ongoing activities in a broader way i.e. the SAI as a whole. Keeping in view this aspect the proposal was deferred. Further, it was directed that the proposal may be put up on file considering the all aspects for example location, space, staff required etc for concurrence.

10.0 Item No. 5
Procurement of Sports Science Equipment for SAI Centres, identified as priority centres for holding of National Camps

Concurred for the approval of Governing Body. It was directed to maintain the legacy value of the equipments procured.

11.0 Item No. 6
Raising of Air Force Boys Sports Squadrons (AFBSS) for Boxing and Wrestling at Air Force Station, Belgaum (Non hilly Area)

Concurred in principle for the approval of Governing Body. Further, it was directed that the proposal with more details may be placed in the next meeting of Finance Committee.

12.0 Item No. 7
Providing of Honorarium to Mentor/Guru under Indigenous Games & Martial Arts (IGMA) Scheme

Deferred. Further, it was directed that the proposal with more details may be placed in the next meeting of Finance Committee.

13.0 Item No. 8
Approval for excess over administrative approval and expenditure sanction up to 10% over and above the approved amount

Concurred for the approval of Governing Body.

Purchase of Tractor Trolley, Disc Harrow, Tiller, Gang Mower and other allied accessories on replacement basis

Concurred for the approval of Governing Body.

- 15.0 **Item No. 10**
Renovation/Up-gradation of existing infrastructures and new project to be undertaken at SAI Special Area Games (SAG) Centre Tinsukia(Assam) at an estimated cost of Rs. 3300 lakhs

Concurred in principle for the approval of Governing Body. The provision for funds is to be made in a phased manner.

Completion of balance works for Tennis Court 2 (Two) Nos. at an estimated cost of Rs. 50.97 lakhs

Concurred for the approval of Governing Body.

- 17.0 **Item No. 12**
Completion of balance works for Synthetic Hockey Surface at Imphal at an estimated cost of Rs.593.00 lakhs

Concurred for the approval of Governing Body.

- 18.0 **Item No. 13**
Laying of Synthetic Athletic Track at SAI NERC, Imphal (balance work) at an estimated cost of Rs. 759.25 lakhs

Concurred for the approval of Governing Body.

- 19.0 **Supplementary Item No. 1**
Replacement of Synthetic Hockey Surface at SAI NSSC Bangalore including providing 600 lux Flood lighting at an estimated cost of Rs. 861 lakhs (Rs. 582 lakhs for Synthetic Hockey including other accessories of Rs. 289 lakhs for Flood lighting)

Deferred in view of paucity of budget provisions.
