Sub: **Engagement of Senior Executive Director on deputation/contract basis.**

Sports Authority of India, Delhi under the Ministry of Youth Affairs & Sports, Government of India invites applications for the engagement of Senior Executive Director on deputation/contractual basis initially for a period of three years extendable by another three years.

A) Qualification : *

Essential – Graduation in any discipline
Desirable - Post Graduate Degree in Management

* Not for deputationists.

B) Eligibility Criteria:

(i) For Deputation

From amongst Officers working regularly in pay level 13 for a minimum of three years under the Central Government or State Government or Union Territory Administrations (including their attached and subordinate offices) or Universities or Public Sector Undertakings or Statutory or Autonomous Organizations with an overall experience of 15 years and 4 years in sports administration.

(ii) For Contract

Minimum 15 years of experience out of which 4 years should be in sports administration.

(iii) Age

Not less than 35 years and not exceeding 56 years for initial appointment.

C) Remuneration :

- (i) For deputation (including short-term contract) Level 14 in Pay Matrix – Rs.1,44,200-2,18,200 as per 7th CPC plus allowances as per rule.
- (ii) For Direct Recruitment on contract basis: Consolidated remuneration of Rs.2,25,000/- per month with 3% annual increment based on satisfactory performance.

D) How to apply:

Application along with detailed biodata containing email id, phone number etc. may reach the office of Director (Pers. & Coaching), Sports Authority of India, Jawaharlal Nehru Stadium Complex, Gate No. 10, Lodhi Road, New Delhi- 110003, on or before of 13th September, 2019. Those who are applying for deputation may enclose their expression of interest to join SAI along with copy of APAR. Short listed candidate will be required to submit Vigilance Clearance, Cadre Clearance, NOC from the department where they are working and attested copy of APAR dossier of the past 05 years within 15 days.

E) Walk-in-interview :

A personal interaction with the eligible candidate will be held on 16th September, 2019 (from 11:00 AM for those who are applying on deputation and from 02:00PM for those who are applying on contract) in the office of the Secretary, Sports Authority of India, Jawaharlal Nehru Stadium Complex, Gate No. 10, Lodhi Road, New Delhi- 110003. The candidate who fulfilling the eligibility criteria may appear for the walk-in-interview along with all documents with respect to the educational qualification and experience in original along with self attested photocopies of the documents and two recent passport size photos.

NOTE: *Officers appointed on contract basis would not be entitled to residential accommodation, official transport, leave encashment or any other allowances as admissible to a regular Government employee. Leave rules applicable to a regular Government employee will not be applicable to a Direct recruit on contract basis. However, the person appointed on contract basis will be entitled to 30 days leave on a pro-rata basis in a calendar year.*
