During the meeting, the prospective bidders raised the following queries. The clarifications provided by the committee are tabulated below:

S. No.	Queries Raised by the Prospective Bidder	Clarification / Reply by the Committee
1.	The bidder sought clarification as to whether registration under the Chhattisgarh Shops and Establishments Act (Gumasta) is mandatory.	The Committee clarified that submission of the Registration Certificate under the Chhattisgarh Shops and Establishments Act (Gumasta) is mandatory, as per the terms and conditions of the tender.

2.	The bidder sought clarification regarding the type of works that would be considered under the similar category.	The Committee clarified that the definition and scope of similar category works have been specified in the ATC of the tender at Page Nos. 9-10. Bidders are required to refer to the said provisions for determining eligibility under the similar category.
3.	The bidder sought clarification as to whether exemption from the prescribed experience criteria would be available.	The Committee clarified that bidders registered under the MSE category or under the relevant category, as applicable under the tender conditions, shall be eligible for exemption from the experience criteria, subject to fulfilment of the applicable conditions.
4.	The bidder sought clarification as to whether the same firm can participate separately in the tenders published for Madhya Pradesh and Chhattisgarh.	The Committee clarified that the same firm may participate separately in the tenders published for Madhya Pradesh and Chhattisgarh, subject to fulfilment of the respective tender terms and conditions.
5.	The bidder sought clarification as to whether submission of a BOQ/price bid is required in the present tender.	The Committee clarified that, being a case of empanelment, the price bid is not applicable at this stage. However, participating bidders are required to quote ₹100/- in the price part of the bid on the GeM Portal, as applicable.

During the meeting, the Chairman of the Committee further highlighted the important terms and conditions of the tender for the benefit of the prospective bidders.

The committee recommended publishing the above clarification for information of all prospective bidders.
