### Corrigendum - 02

Sub: IFB No. SAI-TD/26-35/Insurance-National Campers/2016-17 dated 08.08.2016 for procurement of Medical Insurance & Personal Accident Policy.

Following amendments are hereby authorized to the subject IFB:-

**1. Section – I Invitation for On-line bids (IFB).**

Add the following under column 'Persons'.

- "Figure of 3500 persons is tentative".
- Existing age Groups under column "Brief description of Services" may be amended to read as under:-

5.	56-60
6.	61 and above.

- Under column 'Amount of Earnest Money and 'Bidding Document Cost'. Provision of Earnest Money of Rs. 50,000 and Bid document cost of Rs. 10,000 may be deleted.

**2. Section – II –A Instructions to Bidders (ITB).**

- Clauses 12.1 to 12.7 may be deleted.
- Clause 21.1 – Comparison of Bids & Award Criteria.

For :	Existing Entries.
Read :	"For comparison for ranking purpose for evaluation the comparison of responsive bids shall be carried out on average of all Age Group slabs on all inclusive basis.

**3. Section – III –A "Qualification Criteria".**

Add the following Note against S. No. 2 (vi), (vii) & (viii).

"Note:- Only declarations may be submitted with the on-line bid. Detailed documents to be submitted in Hard Copy separately to the purchaser a day before opening of Technical Bid".

4. **Section – IV – (B) “Price Schedule”**

Price Schedule Table may be amended as under:-

**Total cost in words for Mediclaim and Total Cost in words for Personal Accident Policy may be deleted.**

5. **Section – V – “ Schedule of Requirement”.**

Under Column “Brief description of goods” Age Groups may be amended to read as under:-

6. **Section – VI – “Scope Of Work”.**

a) Clause 1.2 – In patient Hospitalization.

1.2(a) Pre & Post hospitalization – Add the following after existing entries:-

“30 days for pre-hospitalisation and 60 days for post hospitalisation”.

b) 1.2 (b) Room Rent – Add the following after existing entries:-

“In normal cases room rent @ 1% of sum insured and for ICU @2% of sum insured”.

c) 1.2 (c) Nursing Expenses – Add the following after existing entries:-

“Expenses reimbursable as per entitlement”

d) 1.2 (d) Medical Practitioner/Anesthetist, Consultant fees.

“Expenses reimbursable as per entitlement”.

e) 1.2 (e) Expenses on Anesthesia ..... and similar expenses -

Add the following after existing entries:-

“All expenses are payable by Insurance Co.”


- f) 1.2 (j) 'Ambulance Charges' – Add the following after existing entries:-  
“At actual upto a maximum of Rs. 2000/-”.
- g) Clause 2 – Personal Accidental Insurance Policy -  
Words “Weekly compensation” appearing in line 4 may be deleted.
- h) Clause 2 (i), (ii) (iii) & (iv) - May be amended to read as under:-  
2 (i) Accidental Death – 100%.  
(ii) Permanent total disablement – 100%  
(iii) Permanent partial disablement: As per disability.  
(iv) Terrorism risk covered.
- i) Clause 2 (v) – ‘Any other Insurance cover’ – may be deleted.
- j) Clause 3 – Obligations of Insurance Co.  
a) Clause 3 (a) – may be deleted.  
b) Clause 3 (c) – may be deleted.  
c) Clause 3 (f) - Add the following after existing entries.  
“Data to be provided by 1<sup>st</sup> week of subsequent Month”.  
d) Add a following Note after Clause 3 (i)  
“Note – Photo is required for availing Insurance”.

**7. Section – VII – “General Conditions of Contract”.**

- a) Clauses 3 – Performance Security – may be deleted.
- b) Clause 17 – ‘Obligations of Insurance Company’- Add the following after existing entries.“Policy holder Servicing Turnaround Times for different services shall be as prescribed by IRDA in its handbook on Health Insurance. Any delay beyond the prescribed period shall be subject to levy of Liquidated Damages in terms of Clause 8 above”.
8. “Consequently, Critical Date Sheet may be amended to read as under”:-

Bid Submission End Date	06 October, 2016 (06.00 PM)
Technical Bid Opening Date	07 October, 2016 (02.30 PM)

9. All other entries shall remain unaltered.
